To vote against any question(s), fill in the oval next to the word "No".</p> <p>Public Measure BZ</p> <p>Shall the following public measure be adopted?</p> <p>Shall the Board of Directors of the Sumner-Fredericksburg Community School District in the County of Bremer, Chickasaw, and Fayette, State of Iowa, be authorized for a period of ten (10) years, to levy and impose a voter approved physical plant and equipment tax not to exceed One Dollar and Thirty-Four Cents (\$1.34) per one thousand dollars (\$1,000.00) of assessed valuation of the taxable property within the school district, and be authorized annually, in combination, as determined by the board, to levy a physical plant and equipment property tax upon all the taxable property within the school district commencing with the levy of property taxes for collection in the fiscal year beginning July 1, 2020, and to impose a physical plant and equipment income surtax upon the state individual income tax of each individual income taxpayer resident in the school district on December 31 for each calendar year commencing with the 2020 calendar year, or each year thereafter, (the percent of income surtax not to exceed Ten percent (10%) to be determined by the board each year), to be used for the purposes permitted by Iowa law?</p> <p><input type="radio"/> Yes</p> <p><input type="radio"/> No</p>
