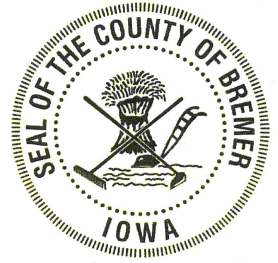

Constitutional Amendment

Shall the following amendment to the Constitution be adopted?

1

Summary: Provides that the right of the people of Iowa to keep and bear arms shall not be infringed. The sovereign state of Iowa affirms and recognizes the right to keep and bear arms as a fundamental right. Any and all restrictions of this right shall be subject to strict scrutiny.

Full Text:

Article I of the Constitution of the State of Iowa is amended by adding the following new section: Right to keep and bear arms. Sec. 1A. The right of the people to keep and bear arms shall not be infringed. The sovereign state of Iowa affirms and recognizes this right to be a fundamental individual right. Any and all restrictions of this right shall be subject to strict scrutiny.

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

Summary: To authorize imposition of a **local sales and services tax** in the unincorporated area of Bremer County, Iowa at the rate of one percent (1%) to be effective on July 1, 2023.

A **local sales and services tax** shall be imposed in the unincorporated area of Bremer County, Iowa at the rate of one percent (1%) to be effective on July 1, 2023.

Revenues from the sales and services tax shall be allocated as follows:

0% for property tax relief

The specific purpose for which the revenues shall otherwise be expended is:

100%

for funding Courthouse remodeling and construction project, including acquisition of equipment and capital improvements; construction, maintenance and repair of county buildings; repair and construction of secondary roads, bridges, culverts and related infrastructure projects; and any other lawful purpose of the county as determined from time to time by the Board of Supervisors.
